Candidate biographies are limited to 300 words. The biographical insert for larger elections (General Employees Retirement Plan and Unclassified Retirement Plan) typically runs about 4 pages total. For the smaller elections (State Patrol Plan, Correctional Plan, Retired employees), typically one page.

5	Historically, how many candidates are there for each election cycle?		Last election, the largest election (General Employees Retirement Plan and Unclassified Retirement Plan) had 13 candidates. Elections for smaller plans typically have fewer candidates.
6	Is there a write-in space on the ballot for each open position? (The RFP mentions having only 1 or 2 write in spaces, however some election cycles will have three open positions on the ballot.)	RFP, pg. 4	While there may be three open positions in an election cycle, they are not for the same representation group/plan. There will be multiple ballots, but there never will be an election where members are voting for more than two candidates per representation group.
7	Has MSRS (or the election vendor) sent out emails to voters in the past? Would MSRS be open to adding email notifications for those voters with email addresses on file?		Emails are not sent and will not be a part of the notification process. Notification will be managed internally by MSRS.
8	As opposed to validating only the online ballot if a voter casts both a paper and online ballot, or disqualifying all paper ballots if more than one is received (pg. 5, #6 under Exhibit A, Scope of Work), would MSRS be open to having only the first ballot received processed (whether online or paper)? Our system is fully capable of having the online ballot take precedence if a voter casts both a paper and online ballot.
